The *Private Sector Engagement Specialist* supports the successful execution of the "Landscape-Scale Conservation in the Ecuadorian Amazon" project in the North Amazon Landscape funded by Procter and Gamble (P&G). This project aims to create a model that balances economic production and environmental protection, while improving local and Indigenous livelihoods through better governance, forest management, and sustainable production practices. Under the supervision of the North Amazon Landscape Manager, the Private Sector Engagement Specialist will design and lead a private sector engagement strategy for the project and participate in roundtables and committees involved with the private sector, identifying strategic opportunities for collaboration and engagement, leverage funds, positionate nature and conservation values within the sector, and support the team in connecting landscape work to markets, effectively and value chains strategies. The Specialist will also visualize strategies to integrate multi-stakeholder and multi-sector participation at a landscape level, in close coordination with the Sustainable Production Specialist and Community Conservation Coordinator.

The Specialist works in close collaboration with CI-Ecuador's Amazon Program Director, North Amazon Landscape Manager and teams across the Amazon, as well as with corporate, NGO, industry association, and in some cases government partners to achieve project objectives. The Specialist does not have direct supervision responsibilities but coordinates with other teams across CI.

- Bachelor's degree. Advanced degree or graduate studies preferred.
- 5-7 years' work experience in managing conservation, sustainable agriculture, value chain work and private sector engagement.
- Proven experience developing strategies for private sector engagement and market linkages.
- Proven ability to understand, interpret and apply technical and scientific information and data to achieve tangible results.
- Knowledge of the political, social, cultural, environmental, and development context in Ecuador.
- Excellent oral, written and interpersonal communication skills in English and Spanish.
- Strong attention to detail and organizational and time management skills.
- Proven ability to work in a team environment and work well across cultures and within and across organizations.
- Proven ability to multitask and meet priorities. Comfortable working in a fast-paced environment with changing priorities and under minimal supervision.
- Knowledge of the agricultural sector in Ecuador, specifically the palm oil sector, is highly favorable.
- Proficient in Microsoft Office.
- Fluency in English required.
