1. Workshop Overview

The Global Environment Facility (GEF) through Conservational International (CI) provided funding to support the Government of Uganda (GOU) to meet the transparency requirements in the Paris Agreement as stipulated under Article 13. The project is intended to support Climate Change Department (CCD) in the Ministry of Water and Environment (MWE), strengthen institutional arrangements for GHG data collection and processing in 5 key emission sectors (agriculture and land use; forestry, energy, transport and waste) as well as build Capacity of stakeholders on data collection and processing. The project targets to enhance the capacity and skills necessary for effective and efficient operationalization and functioning of the National GHG Inventory (GHGI) and MRV system. The project is implemented by the Ministry of Water and Environment (CCD) and Africa Innovations Institute (AfrII)/ Vital Signs. The implementing partners (MWE-CCD, AfrII and Vital Signs) organized a launch and project inception workshop on 3rd October 2018, at Hotel Africana, Kampala, Uganda.

1.1. Workshop objectives

The main objective of the workshop was to officially launch the CBIT project and share with stakeholders the different components in the project. The workshop brought together all stakeholders including representatives from government agencies, particularly from the key emission sectors, the private sector, development partners, academia, media and development partners to understand and discuss the planned project outputs and expected outcomes.

The specific objectives were:

- i. To officially launch the capacity building initiative for transparency project
- ii. Give stakeholders a better understanding and clarification of roles within the CBIT Project, the objectives, outcomes, outputs and planned activities.
- iii. Get insights of how the major stakeholders are engaged in the GHGI and MRV systems in Uganda
- iv. Get insights of how each sector is involved and contributes to the GHGI and MRV systems

1.2. Workshop outcomes

The workshop outcomes include:


- The project officially launched by the Minister of State (Environment).
- Stakeholder input into the CBIT project workplan, planned activities, outputs and outcomes.
- A general understanding of how key stakeholder are engaged in the GHGI and MRV systems in Uganda.
- A general understanding of how different sectors contribute to GHGI and MRV systems and challenges involved in the process.
- List of organizations involved in the GHGI and MRV systems for potential synergies and partnerships



2. Highlights and achievements

2.1. Official launch of the CBIT Project

The Capacity Building Initiative for Transparency (CBIT) official launch was attended by 52 participants. The sex of participants was as show below.



About 62% of the participants were aged 18 to 40 years and the rest were above 41 years old. Participants represented 24 institutions including government Ministries, Departments and Agencies (MDA), Development Partners, Non-Government Organizations, Civil Society Organizations, Academia, and the Media. The diverse network of participants was a great opportunity for project visibility. The official launch of the project was done by Honorable Kitutu K Mary Goretti, the State Minister for Environment.

The CBIT project brief and workplan presentation triggered a lot of discussion among the stakeholders and brought to fore the need for capacity building on GHGI and MRV systems. The discussions also brought in concerns of sustainability of the project activities post funding and data sharing challenges that already exist. The major resolution following the discussion was to have stakeholder buy-in through stakeholder engagement in project implementation at institutional and sector levels.

An individual and group assessment was carried out during the inception workshop to give a general understanding of where the different sectors are engaged in the GHGI and MRV systems. The group discussions revealed that there are already identified focal points for the different sectors in relation to GHGI and MRV and a network for data collection is in place. Participants highlighted the biggest









challenges as inadequate skills in data collection, processing, analysis and interpretation and unclear roles and responsibilities of the different institutions involved in GHGI and MRV systems.

Workshop participants identified the various initiatives already ongoing or being planned to commence shortly from the various stakeholders including plans by development partners for example;

- i. The GGGI are developing the national MRV system,
- ii. UNDP and GIZ are supporting NDC implementation programme.

As a result, a list of potential partnerships and synergies come out of this meeting thus enriching the CBIT project workplan to avoid duplication of activities and effectively use the available resources.

During the CBIT inception workshop first NDC partnership meeting in Uganda took place as a side event during lunch break. This meeting focused on synergies and partnerships in the GHGI and MRV areas to avoid duplication of activities and ensure effective utilization of the limited resources. 12 participants from eight institutions (UNDP, CI, AfrII, MWE, CCD, ADB, GIZ, GGGI) key agencies in resource mobilization and activity implementation to this regard attended this side event.

3. Way Forward

Partnerships and synergies were recommended with the organizations involved in the GHGI and MRV systems. This will ensure efficient and effective use of the available resources in addition to joining efforts in developing robust GHGI and MRV systems for Uganda. It is hoped that with support from the stakeholders, CBIT will enhance tracking and reporting on the GHG emissions for Uganda.
