The research team will provide a leaflet to any participant with detailed information how to communicate any complaints and grievances. In the case of grievances reported by phone, the grievances responsible, or any project team member being present in the office, will fill out a grievance note, including the name, contact details of the claimant, date of complaint and the detailed description of the complaint/ grievance, as well as any comments or suggestions of how to address the complaint. For any grievances submitted by the same information is recorded.

The grievance responsible will respond in writing to any claimant within 15 days and take immediate action to address those grievances in consultation with the claimant if any resource restriction has been caused by the project. Claims, responses and actions taken to address grievances will be filed and included in project monitoring

## **II. Unsatisfied complaints:**

If the claimant is not satisfied with the response by the grievance responsible, the grievance may be submitted to Conservation International Japan (CI Japan), the chair of the Executive Team, directly at:
