The Technical Coordinator manages and leads assigned projects to build a healthy sustainable society in Suriname and to promote CI Suriname's goals. S/He primarily co-designs and implements those projects and gives other technical support, where requested. S/He is responsible for defining and implementing the project implementation strategy and to direct the project course.

S/He will have regular contact with partners, donors, community members and government officials in the course of carrying out his/her duties.

The Technical Coordinator reports to the Technical Manager and oversees the work of colleagues and consultants assigned to her project as the project team leader.

- Participate in national and international meetings to promote and support national and organizational positions

- Assist with GIS related tasks to map and visualize threats, key areas for conservation and other activities of interest
