The Policy Manager works closely with internal and external stakeholders in developing and implementing policy objectives while managing daily relations with external stakeholders.

S/He ensures relevant policy information is disseminated, engaging decision makers and favorably influences CIS' policy and conservation goals.

The Policy Manager supports fundraising and proposal efforts to help secure funding for policy initiatives. S/He aligns CIS' thematic and geographic strategic ambitions with national commitments, developing objectives to contribute to national conservation priorities and policies.

S/He reports to the Technical Director and works in close collaboration with the Development & Communications Director, and the Technical department.
