Consultancy: Feasibility Study Climate Finance and Biodiversity Mechanism in Suriname

Conservation International Suriname (CI Suriname) is looking for a consultant for a **Feasibility Study Climate Finance and Biodiversity Mechanism in Suriname** to execute project activities for a period of 6 months.

The main objective of this consultancy is to develop a feasibility study for a carbon offset with links to Natural Climate Solutions (NCS) in Suriname, to explore its potential and make recommendations as to a preliminary design of the offset. The study should focus on the revenues from the opt in carbon offset linked to defined conservation activities that promote and invest in NCS, such as, but not limited to

- support of domestic nature-based conservation, mitigation and adaptation efforts
- readiness efforts for the generation of carbon offsetting projects
- other government priorities

Requirements

- Have legal expertise in offset policy in Suriname.
- Preferably have experience in the design of carbon pricing mechanisms or similar financial mechanisms in the region.
- Have working fluency in English and Dutch.
- Have proven experience engaging with the government and private sector in Suriname for policy development.

- Education Requirement - 3 pts
- Work Experience Requirement- 3 pts
- Strong communication and presentation skills including the ability to effectively convey complex details or technical information - 3 pts
- Experience with similar projects- 3 pts

- Experience in the design of carbon pricing mechanisms or similar financial mechanisms in the region - 3 pts
- English and Dutch proficiency, both in speaking and writing - 3 pts
- Highly familiar in engaging with the government and private sector in Suriname for policy development - 3 pts
- Comprehensive proposal on how to conduct feasibility studies on carbon offsets - 3 pts
